NOW THEREFORE, In consideration of the mutual covenants and promises herein contained, the Owner and Organization agree as follows:

Fiddlers Green hereby grants _____ a non-exclusive right to copy, sell and distribute FG card model products under the terms outlines below.

All rights, title and interest in the material, including without limitation, any copyright, shall remain with Fiddlers Green.

Under the terms of this agreement, Owner freely offers:

- a. Digital model storage on Owner's server
- b. Updates, corrections, and new versions to all Owner's models.
- c. A fiddlersgreen.net listing and link to Organization's Business.

Under the terms of this agreement, The Organization has the following permissions from the Owner:

- a. Print UNLIMITED quantities of ALL FG models
- b. Print any size of FG models
- c. Sell FG models retail for any price.
- d. Sell printed FG models from Organization's Museum Shop, Business (and/or Internet Shop)
- e. Sell printed models wholesale to local hobby shops, at craft fairs etc
- f. Copy up to 5 digital models on a CD as a premium for (ie:) membership or membership renewal in Organization's museum or organization

Under the terms of this agreement, The Organization must:

- a. Remit \$_____ for an annual License to print and sell FG models
- b. Renew promptly when the year is up to maintain license in good standing.

Under the terms of this agreement, The Organization is not permitted to:

- a. Sell downloadable Fiddlersgreen digital models over the Internet including eBay, Amazon etc.
- b. Sell CDs or DVDs of Fiddlersgreen models
- d. Remove or alter FiddlersGreen copyright information
- e. Alter designs without Owner's permission
- f. Create new models using Fiddlersgreen name

This Agreement may be terminated by the written agreement of both parties.

In the event that either party shall be in default of its material obligations under this Agreement and shall fail to remedy such default within ten (10) days after receipt of written notice thereof, this Agreement shall terminate upon expiration of the ten (10) day period.

This Agreement constitutes the entire and only agreement between the parties and all other prior negotiations, agreements, representations and understandings are superseded hereby.

This Agreement shall be construed and enforced in accordance with the laws of the United States of America.
